**Vote on Main Motion:** The motion passed unanimously.


**B. Other as properly presented.**

Mayor Wissman called for a motion to adjourn. Alderman McGee made a motion to adjourn. Vice Mayor McKee seconded the motion.


Mayor Wissman advised that the Beer Board Meeting had been adjourned.
