Mayor Wissman called the meeting to order and advised that a quorum was established. All members are present.

II. APPROVAL OF THE MINUTES FROM JANUARY 3, 2017

Motion: Alderman McKee made a motion to approve the minutes from the January 3, 2017 Beer Board Meeting. Alderman Thompson seconded the motion.

The motion carried unanimously.

III. OLD BUSINESS

A. Other as Properly Presented

1. There was no old business brought forward.

IV. NEW BUSINESS

A. Application for OFF Premise Beer Permit for Seasons Square LLC located at 5847 Airline Road Suite 101 in Arlington, Tennessee.

Mayor Wissman recognized Gerald Lawson, Town Attorney. He advised that a background check had been performed and no records were found. He stated that staff recommended approval.

Mayor Wissman called for a motion.

Main Motion: Alderman Harmon made a motion to approve the OFF Premise Beer Permit for Seasons Square LLC, located at 5847 Airline Road Suite 101, in Arlington, Tennessee. Alderman Brooks seconded the motion.

Mayor Wissman called for discussions or questions. After hearing no further discussion, Mayor Wissman called for a vote on the main motion.

Vote on Main Motion: The motion passed unanimously.

B. Application for OFF Premise Beer Permit for Arlington Tobacco located at 11615 Highway 70 Suite 101 in Arlington, Tennessee.

Mayor Wissman recognized Gerald Lawson, Town Attorney. He advised that this application was pulled at the applicant's request.

C. Violation of OFF Premise Beer Permit at Airline Shell, located at 5055 Airline Road in Arlington, Tennessee.

Mayor Wissman recognized Gerald Lawson, Town Attorney. He advised that there was a violation at Airline Shell and noted that the owner and attorney was present. He explained that this is a new owner at this location and this should be treated as a first offense. He stated that since this being the first offense, he recommends a \$1,000 fine because they are aware of the Responsible Vendor's Act.

Mayor Wissman called for a motion.

Main Motion: Alderman Brooks made a motion to assess a \$1,000 fine for the first offense to Airline Shell located at 5055 Airline Road. Vice Mayor McKee seconded the motion.

Mayor Wissman called for discussions or questions. Daniel Seward, Attorney for Airline Shell, stated that he has made his clients aware of the Tennessee Responsible Vendor's Act. Vice Mayor McKee inquired about the Point of Sale software that the owner has in place. After hearing no further discussion, Mayor Wissman called for a vote on the main motion.

Vote on Main Motion: The motion passed unanimously.

D. Violation of OFF Premise Beer Permit at Bloomingair, LLC DBA Arlington Travel Center, located at 4935 Airline Road in Arlington, Tennessee.

Mayor Wissman recognized Gerald Lawson, Town Attorney. He advised that there was a violation at Arlington Travel Center and noted that the owner was present along with the Shelby County Sheriff's Officer who conducted the sting. Deputy Roman was sworn in and explained the scenario that took place on March 17, 2017. She explained that the Identification was checked. Mr. Lawson stated that since this being the first offense, staff recommends a \$1,000 fine because they are aware of the Responsible Vendor's Act. Amirali Moosani, owner of Bloomingair LLC, spoke to the Point of Sale system that they have in the store. Currently, they must manually enter the birth dates of customer. There was discussion about the transaction. Mr. Lawson explained that this was the third offense within three years and stated the past amounts of fines imposed on the business.

Mayor Wissman called for a motion.

Main Motion: Alderman Brooks made a motion to assess a 30-day suspension for the third offense to Arlington Travel Center located at 4935 Airline Road. Alderman McKee seconded the motion.

Mayor Wissman called for discussions or questions. After hearing no further discussion, Mayor Wissman called for a vote on the main motion.

Vote on Main Motion: The motion passed unanimously.

E. Other as properly presented.

There was no further business brought before the board.

V. ADJOURNMENT


Mayor Wissman called for a motion to adjourn.

Motion: Alderman Brooks made a motion to adjourn. Alderman Thompson seconded the motion.


Mayor Wissman advised that the Beer Board Meeting had been adjourned.




