### II. APPROVAL OF THE MINUTES FROM THE MAY 5, 2014.

**Motion:** Vice Mayor McKee made a motion to approve the minutes from the June 2, 2014 Beer Board Meeting. Alderman Brooks seconded the motion. The motion carried unanimously.

### IV. NEW BUSINESS

#### A. Off-Premise Beer Permit Application for Bloomingair, LLC, DBA Arlington Travel Center located at 4935 Airline Road in Arlington, Tennessee, due to change in ownership.

Mayor Wissman recognized Gerald Lawson, Attorney who advised that a background check on Mr. Moosani had been performed and no records were found. He stated that the Staff recommended approval.

Mayor Wissman called for a motion.

**Motion:** Alderman Thompson made a motion to approve the Off-Premise Beer License Application for Bloomingair, LLC DBA Arlington Travel Center. Alderman McKee seconded the motion.

Mayor Wissman asked for discussions or questions. After hearing no discussion, Mayor Wissman called for a vote.

**Vote on Main Motion:** The motion passed unanimously.

**B. Application for an On-Premise Beer license for Pericos located at 11125 US Highway 70, Suite 109 in Arlington, Tennessee.**

Mayor Wissman recognized Gerald Lawson, Attorney who advised that this application is a result of the change in Beer Ordinance from the August Board of Mayor and Aldermen meeting. Mr. Lawson stated that this location meets all of the distance requirements and that the staff recommends approval on the condition that the minutes from last month's meeting are passed into record.

Mayor Wissman called for a motion.

**Motion:** Alderman Brooks made a motion to approve the On-Premise Beer license for Pericos on the condition that the minutes from last month's meeting are passed into record. Alderman Thompson seconded the motion.


Mayor Wissman called for discussions or questions. Alderman McGee asked for the distances from the restaurant to the Arlington Assembly of God Church and Kim's Kid's Corral Daycare. Heather Sparkes, Town Planner stated that from the back door of the daycare to the restaurant was 503 feet while Arlington Assembly of God Church was over 1000 feet. After hearing no further discussion, Mayor Wissman called for a vote.

**Vote on Main Motion:** The motion carried unanimously.
