IV. New Business

A. Second and Final Reading of Ordinance 2015-06 to further amend the Town of Arlington, Tennessee, Budget for Fiscal Year ending June 30, 2015.

Mayor Wissman called for discussion or questions. After hearing no further discussion, Mayor Wissman called for a vote on the main motion.


Vote on Main Motion: The motion carried unanimously.

The motion carried unanimously.




