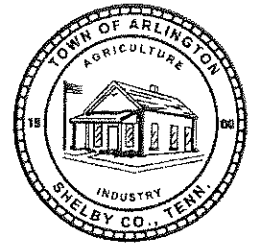

Vice Mayor Harry McKee called the meeting to order and advised that a quorum was established.

### II. Approval of the minutes from November 5, 2018.

**Motion:** Alderman Brooks made a motion to approve the Beer Board minutes from November 5, 2018. Alderman Biggs seconded the motion.

### III. Old Business.

### IV. New Business.

#### A. Violation of OFF Premise Beer Permit for Arlington Market and Deli, located at 6115 Airline Road in Arlington, Tennessee.

Vice Mayor recognized Gerald Lawson, Town Attorney. Mr. Lawson stated the Sheriff's Department conducted a sting operation on August 27, 2018. On this date the clerk on duty sold alcohol to a minor. Mr. Lawson noted that this is their first violation. Staff recommends a fine of \$2,000. Mr. Lawson turned to William Causie, who represented the business, asking him if he understands the violation presented and the payment of the fine. Mr. Causie agreed. Mr. Lawson inquired about preventive measures that would be put in place for the future. Mr.

Causie stated that further training will be conducted. Vice Mayor McKee asked if they participate in the Responsible Vendor Program. Mr. Causie confirmed that they were are.

Vice Mayor McKee called for a motion.

**Main Motion:** Vice Mayor McKee made a motion to approve the violation fine of \$2,000 be applied to Airline Market and Deli. Alderman Brooks seconded the motion.

Hearing no further comments or concern, Vice Mayor McKee called for a motion.

**Vote on Main Motion:** Motion carried unanimously.

**B. Violation of ON Premise Beer Permit for El Mezcal, located at 11615 Highway, Suite 104 in Arlington, Tennessee**

Vice Mayor McKee recognized Gerald Lawson, Town Attorney. Mr. Lawson stated the Sheriff's Department conducted a sting operation on August 27, 2018. On this date a server sold alcohol to a minor. Mr. Lawson noted that this is their second violation. Staff recommends a fine of \$2,500. Mr. Lawson turned to Jesus Alvarez who represented the business, asking him if he understands the violation and the payment of the fine. Mr. Alvarez agreed. Mr. Lawson inquired about the preventive measures that would be put in place for the future. Mr. Alvarez stated that further training will be conducted. He has already sent the server to a training class. He stated that the employee did check the ID but was in a rush and didn't really understand what to look at on the ID. Mr. Lawson also stated that since this was their second violation that if it happens again within a two-year period that the permit can be revoked or suspended. Mr. Alvarez stated that he understood.

Vice Mayor McKee called for a motion

**Main Motion:** Vice Mayor McKee made a motion to approve the violation fee of \$2,500 be applied to El Mezcal. Alderman Brooks seconded the motion.

Hearing no further comments or concerns, Vice Mayor McKee called for a motion.

**Vote on Main Motion:** Motion carried unanimously.
